Furthermore, the Foreign Principal Party in Interest understands that civil and criminal penalties may be imposed for making false or fraudulent statements, or for the violation of any United States laws or regulations on exportation.

This power of attorney is to remain in full force and effect until revocation in writing is duly given by the Foreign Principal Party in Interest and received by the Authorized Agent.
